13.05-13.30 Le legal design appliqué à la Déclaration de droits lors de l'arrestation

Droits Quotidiens Legal Design a redesigné la "déclaration des droits belges" remise à toute personne en état d'arrestation. C'est un exemple concret d'application du legal design en droit pénal. Le droit à l'information est nécessaire pour garantir un procès équitable ; mais lorsque les personnes arrêtées ne reçoivent pas ces informations sous une forme accessible, elles ne sont pas en mesure d'exercer leurs droits. Ces droits sont donc illusoires en pratique. Dans ce contexte, en 2018, un groupe d'associations européennes a lancé le projet « Access Just ». Ce projet vise à améliorer l'accès à la justice, principalement en clarifiant l'ensemble des lettres des droits européennes.

Olivier Beaujean est juriste et licencié en communication - journalisme (UCLouvain). Il est expert de langage clair/legal design. 13.30-13.55 Dark patterns under the EU regulatory loupe Agustín Reyna

Consumers increasingly face "dark patterns" because on-line user interfaces are designed to deceive consumers to take decisions that are not in their favour but serve companies' commercial interest. The use of unfair practices to distort consumers' economic behaviour is not new, but it takes a new important dimension as a result of the massive collection of data and the use of technology to build consumer profiles and anticipate consumer behaviour. This contribution argues that EU consumer law already has partial capacity to address these situations, but it is currently not sufficiently enforced. In addition, EU law must be updated to tackle these unfair practices and ensure consumers are not harmed by misleading user interfaces and data personalisation techniques.
